As a district, we take the responsibility of being good stewards of our district funds seriously, and while the end of ESSER dollars is a direct impact to all districts' funds, we have worked hard to make sure that loss is not felt in our classrooms.

I am also happy to report our Dual Language Team is continuing to meet and make site visits to exemplary models across the Valley to finalize the model we will use in Phoenix #1. We do not yet know which school or schools will house our Dual Language models but expect to finalize that following Phase II of Reimagine with the community visioning meetings, or charrettes.

- The Annual Financial Report (AFR) is a financial report that recaps the District's revenues and expenses for the fiscal year (July-June)
  - This report is for the 2023/2024 fiscal year (July 2023 June 2024)
  - $\circ~$  The AFR is due to the Arizona Department of Education by October 15th every year
- Outlines revenues and expenses by funding source
  - Maintenance & Operations (M&O)
  - Federal Projects (Title funds, IDEA, Medicaid etc.)
  - Capital Outlay (Capital over-rides)
  - Bond Building (Bond Overrides)
  - Classroom Site (Prop 301 Funds)
- Recaps Revenue and Expense Categories
  - Salaries and related expenses
  - Administration, Instruction, Special Ed, etc.
  - Capital and major expenses
